

# Aston Martin Prize Draw Terms and Conditions

1. Our draw is open to Barclaycard principal card holders who are UK residents, age 18 and over, hold a full valid UK passport and have a Barclaycard account that is open, not in arrears and within its credit limit at the time the draw is made.
