

Terms and Conditions of Amazon.co.uk Gift Card offer

- We are offering an Amazon.co.uk Gift Card of the value of £50 to you, payable only in accordance with the below terms and conditions ("Offer").
- The Offer applies solely in respect of your current cumulative merchant service charges across the following card types: consumer credit, consumer debit, commercial credit, commercial debit (the merchant service charges being the total number of transactions accepted by you each month for such card types, multiplied by the applicable rate for the relevant card type), payable by you to your current third party merchant acquiring service provider (the "Applicable Charges") (being an acquiring entity with a licence to process card transactions) as at the date you "challenge us to beat your rate" (which is the date you call our Telephony Sales team in accordance with the process set out below) ("Current Pricing"). For the avoidance of doubt:
 - American Express®, Diners cards charges and multi-currency (non-sterling) transactions will not be included for the purpose of determining whether you are entitled to payment under the Offer.
 - No other charges will be included for the purpose of determining whether you are entitled to payment under the Offer; and the notification of any single merchant service charge by us which is in excess of any single merchant service charge payable by you as part of your current pricing shall not result in us making any payment to you pursuant to the Offer.
- The process which shall govern the Offer is as follows:
 - Our Sales team will request that you send via email a recent monthly statement ("Statement") or like for like quote ("Quote") that outlines your monthly Current Pricing. The Statement or Quote must be dated within 3 months of the date of us receiving it and the Quote must include an estimate of your aggregate volume or profile (by transaction type and amount) of your card payments. All documentation needs to be received by us within 4 weeks from the date requested by Barclaycard.
 - Our Sales team will advise to you the email address that all relevant correspondence needs to be sent to.
 - Once we receive and review the above documentation, our Sales team will attempt to offer you a rate in respect of the Applicable Charges ("Our Pricing") which is less than your Current Pricing.
 - If Our Pricing is not lower than your Current Pricing, you will be entitled to a £50 Amazon.co.uk Gift Card that will be emailed to you in the form of a digital code.
 - You shall receive the digital Amazon.co.uk Gift Card so long as you have provided us with a valid email address, within 4 weeks of being notified that you are entitled to payment pursuant to the Offer.
- It is at the sole discretion of Barclays to determine if the Statement or Quote received is a 'like for like' comparison with Our Pricing structure.
- You will not be eligible for the Offer if, in the opinion of Barclays, your current terms and conditions are materially different from our terms and conditions. For this purpose, if the minimum contract period with your current merchant acquiring service provider is at least 24 months in respect of acquiring, or any additional services or products related to acquiring, this is deemed a material difference to our terms and conditions.
- The Offer is not open to PSP Solutions, Bureau, Direct Transmission, Day Link and Night Link or Trade Associations.
- Existing customers of Barclaycard Payment Solutions are not eligible for the Offer.
- The Offer only applies to UK based sole traders, partnerships or registered companies who trade in Sterling and whose turnover on card transactions is up to £6.5 million per annum. Retailer turnover is calculated at a chain level and incorporates all outlets.
- The Offer is subject to satisfactory completion by us of our standard searches and checks.
- The start date for the Offer is midnight BST on 8 January 2018. The Offer closes at 17:59 BST on 30 March 2018.
- Barclays reserves the right to vary Our Pricing at any time during the term of the contract.
- The Offer cannot be used in conjunction with any other Barclay's offer, and cannot be utilised more than once by any sole trader, entity or group of entities.
- Barclays reserves the right to withdraw the Offer at any time.
- Should we successfully reduce your merchant service charges but you are subsequently declined for a facility by Barclaycard Payment Solutions you will not qualify for this offer.
- Barclays reserves the right to withhold and/or refuse payment of the digital gift card where we suspect that any false or fraudulent claim is being made.
- You must be free from your contract period with your existing merchant acquiring service provider and be in a position to switch providers to be eligible for this offer.
